## Biography

Taryn Kadar is an insurance coverage lawyer who provides legal counsel to domestic and international insurers – including Lloyd’s syndicates and London market insurers – on complex U.S. insurance coverage matters. Her practice focuses on high-value commercial property and general liability claims, with a proven track record in high-stakes litigation, including declaratory judgment actions and the defense of breach of contract and bad death claims arising from both first- and third-party losses.

Taryn is widely recognized for her understanding of the unique challenges faced by the London insurance market in U.S. litigation. She played a significant role in the market’s response to COVID-19 claims, advising on the application of virus and microorganism exclusions and addressing the need for “direct physical loss” to trigger coverage. She has also advised insurers on multi-million-dollar property claims following Hurricanes Irma and Maria, handling complex, multi-jurisdictional losses across the southeastern United States and the Caribbean.

Additionally, Taryn regularly advises on coverage issues involving large-scale infrastructure projects, including bridges, tunnels, and other major developments. She also represents insurers in aviation-related coverage disputes, including high-profile claims involving Western-owned aircraft left in Russia amid the ongoing conflict in Ukraine.

Taryn was twice seconded, spending time with two leading Lloyd’s syndicates where she worked directly with in-house legal and claims teams on a wide spectrum of U.S. and international claims. Her experience spans marine, reinsurance, contingency, cargo, and professional indemnity lines. There, she advised underwriters on U.S. policy wordings, claims strategy, and litigation management.

Taryn earned her Juris Doctor from Wake Forest University School of Law and her undergraduate degree from Elon University. Her and her husband enjoy traveling with their English Bulldog, Winston, who has been to 5 countries.
